- Soft Chewables for cats (1.5 mg CBD/chewable).
- Soft Chewables for dogs: original and Tater Tot's Sweet Potato (3 mg CBD/chewable).
- Capsules in two potencies: 10 mg CBD for dogs over 100 lbs. and 25 mg CBD for dogs & horses over 200 lbs.
- Topical Cream for dogs & cats in 1 oz (60 mg CBD) and 4 oz (240 mg CBD) containers.
