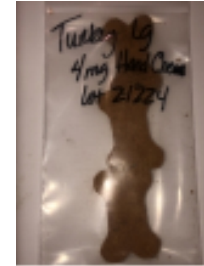

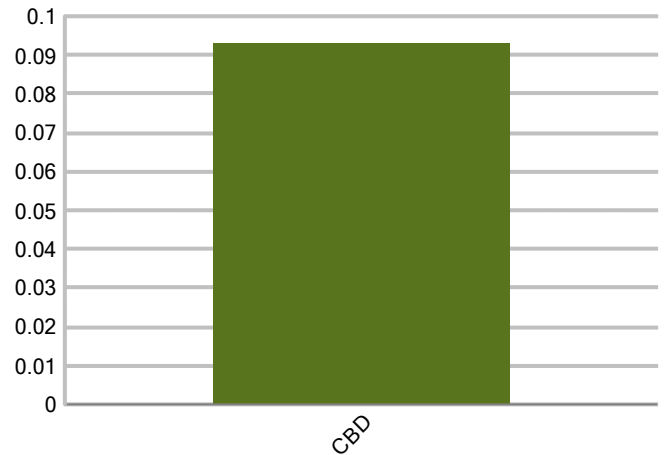

Cannabinoids (% weight)



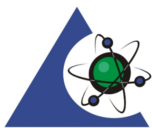

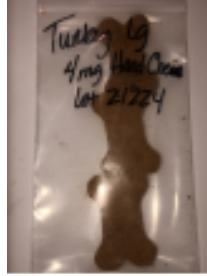
